# Summer Project Updates

Fencing bid came in from Meyer Fencing Construction. For backstop and immediate fencing by backstop \$14,900. 2 dugouts with roof 9'x30' \$4900. Sideline fencing \$12,583.47. All bids were submitted separately. Work would begin in August and go through September depending on weather. Mr Silkett recommends that we go with the bids from Meyer Fencing. David Klamm made a motion to accept the bids. Brian Flora seconded. The motion carried 7-0.

# Substitute Teacher Pay
