The tax rate will go up from 5.902 to 5.9102 due to a slight increase in state assessed the year before. We have also gone up in assessed valuation for the first time after the big bump in AV we got three years ago due to new construction on the KCP&L relay station. Because of the big bump three years ago, we still have too much in our fund 3 account so we will be working with LJ Hart to put \$55,000.00 (on top of the \$40,000 we have set aside this summer) in an account that will trigger in March 2021 when we can pay more on our bonds so we will not have a large decrease in our fund three, .59 cent tax rate. The Tax levy was then set at \$5.9102 including the .59 cent bond.

Rick Holtman made a motion to set the tax rate and Debbie Bennett seconded. The motion carried 5-0.

David Klamm arrived.

Rick Holtman motioned to accept the resolution authorizing the redemption of \$55,000 principal amount of general obligation refunding bonds, series 2016 and authorizing the publication of notice or redemption. Debbie Bennett seconded the motion and a roll call vote was taken. Macia Kemper, yes; Janet Hilsabeck, Yes; Rick Holtman, yes; David Klamm, yes; Brian Flora, yes; and Debbie Bennett, yes.

Macia Kemper then motioned to adjourn the tax rate hearing. Rick Holtman seconded. The motion carried 6-0
